Day 2 Speaker Bios

Tom Mungham, Chief Operating Officer at the Alcohol and Gaming Commission of Ontario

Tom is the Chief Operating Officer at the Alcohol and Gaming Commission of Ontario. With the AGCO since 2006, Tom oversees regulatory operations in the alcohol, horse racing, and commercial casino, lottery and charitable gaming sectors, including: all compliance and regulatory assurance activities; anti money laundering programs; licensing and registration; slot, electronic and internet game and system assessments; and horse racing operations.

Focused primarily on leading change and operations, Tom's working experience includes both the private and public sectors in diverse areas of regulation, law enforcement, correctional services and banking including work in business operations, education and training, information technology, strategic and business planning, audit, and financial management. Tom sits on the Board of the North American Gaming Regulators Association as its Canadian Regional Director, and co-chairs NAGRA's internet gaming interest group.

Jeffrey Silver, Of Counsel at Dickinson Wright, PLLC

Mr. Silver's practice focuses on every aspect of gaming, liquor licensing and regulatory law, as well as planning and zoning matters, contractor licensing and transportation law.

Chamber of Commerce and former Secretary and Director of the Las Vegas Convention and Visitors Authority (LVCVA). He also held positions at various resort hotels, such as COO and General Counsel for the Landmark Hotel & Casino, Chief Executive Officer and member of the Board of Directors of the Riviera Hotel & Casino and Senior Vice-President of Marketing for Caesars Palace.

Jennifer Roberts, Associate Director at the International Center for Gaming Regulation

Jennifer Roberts is the Associate Director of the International Center for Gaming Regulation. Ms. Roberts has practiced gaming law in Nevada since 2003 and was previously a shareholder in the Gaming & Regulatory Department of the Nevada-based law firm of Lionel Sawyer & Collins. In 2002 he was appointed as Executive Director of the Alderney Gambling Control Commission and served in this position until January of 2016.

In his capacity as gaming regulator Wilsenach was instrumental in promoting regulatory best practices around the world. He was the keynote speaker at the first international eGambling Summit held in the United Kingdom in 2006. He provided testimony to the Financial Services Committee of the US House of Representatives concerning the introduction of the Internet Gambling Regulations Enforcement Act, 2007. He was a keynote speaker at the American Gaming Association's 2008 Global Gaming Summit in Las Vegas, and in 2012 provided testimony to the UK Culture, Media and Sport Select Committee regarding their new regulatory framework.

Wilsenach is a former President of the International Association of Gaming Regulators and is an active member of the International Masters of Gaming Law and the International Association of Gaming Advisors.

James Barbee, Chief of the Nevada Gaming Control Board's Technology Division

Jim joined the NGCB in 2000 and was appointed to his present position as Chief of the NGCB's Technology Division in 2011. Philip M. Pro came to Nevada in 1972 to serve a one year judicial clerkship. It has been a long year. After 35 years of service, Judge Pro retired from the federal bench in January 2015. Serving first as United States Magistrate Judge from 1980 to 1987, he was appointed by President Ronald Reagan as United States District Judge for the District of Nevada. He served as Chief Judge from 2002-2007. Throughout his judicial career, Judge Pro presided over hundreds of criminal and civil jury and non-jury trials.

Prior to joining the bench, Judge Pro served as a Clark County Deputy Public Defender (1973-1975), an Assistant United States Attorney (1975-1978), as a Deputy Attorney General for the Nevada Gaming Commission, and in private law practice.

Pro was actively involved in the founding of Boyd Law School, and currently serves a member of the Advisory Board of the Saltman Center for Conflict Resolution. The "Judge Philip Pro Lectureship in Legal History" inaugurated in 2005, is named in his honor. Over the past 25 years, Judge Pro also has participated in dozens of rule of law and judicial training programs in over 20 countries on behalf of the United States Departments of Justice and State, the International Association of Judges and numerous NGO's.

Since retiring from the bench, Judge Pro has provided arbitration and mediation services through JAMS, the largest provider of ADR services in the United States. Additionally, in December 2015, Governor Brian Sandoval appointed Pro as a Member of the Nevada Gaming Commission.
